<b>Eligible entrants:</b>	<ol style="list-style-type: none"> <li>Entry is open to residents of Western Australia only, aged 18 years and over.</li> <li>Employees and immediate families* of the Promoter, Cricket Australia and VenuesWest, and suppliers, providers and other third parties associated with this Competition and any element of the Prize, are ineligible to enter. <i>*Immediate family includes spouse, defacto spouse, parent, natural or adopted child or sibling.</i></li> <li>Entry is open to patrons who have purchased a ticket to Day 1, 2, 3 and/or 4 (14 to 17 December 2018 inclusive) of the Domain Test Australia v India (<b>Event</b>) from the authorised ticketing agent (<b>Ticketmaster</b>), and when purchasing a ticket have agreed to receive information regarding events, products or other services directly from other third parties, in addition to receiving information from Ticketmaster.</li> </ol>

5.
